A MESSAGE FROM THE PRESIDENT

It is with great honor that I have served a second term as President of OCTA for the 2024-2025 OCTA year. Many of the goals I had put forward at the start of this term have been met, and it could not have been done without the tremendous support of the Executive Board - Wayne Kirsch, Jesse Bernal, Rose Roberts-Karnes, Mendell Hibbard, and Aara Wise.

As the following pages contain detailed reports from each division, region, and many of the OCTA board volunteers, I only want to lay out the basic tasks that I set before the board this year. During my 2023-2024 term as president, I presented the board of directors with a 5 Year Strategic Plan that borrowed from the Traction and EOS business models. I created a Vision Traction Organizer meant to align the divisions and the board in its entirety on the future of OCTA and created a 1 Year Plan, a 3 Year Plan, and a 5 Year Plan. With the success of this strategic plan model last year, the intent going into 2025-2026 was to keep the board's momentum forward, continuing with the revamped State Conference, and working to keep Conference both profitable for the organization and affordable for members and participants.

The Bullet Points set for the 1 Year Plan to focus the OCTA Board over the 2024-25 year were:

- 1. A Profitable 2024-2025 Year
- 2. Finalize the revitalized State Conference structure
 - a. Continue putting theatre/hotel contracts in place
 - b. Finalize a Conference Chair Manual, detailing which board positions (including Conference Chair) are responsible for what aspects of the State Conference
 - c. Set State Conference Registration fees for the next 3 years, with detailed explanations as to why increases were being put in place, to be fully transparent with all OCTA members and participants
- 3. Increase membership by re-evaluating the requirements for Member Theatres and Revamping the Individual Membership program
- 4. Continued increase in Communication to all OCTA members, supporters, and volunteers

The 3-year plan remained the same, with the addition of preparing to plan the 2031 AACT Region 3 Regional, which will be hosted by Ohio. The 5-year plan also did not change. The primary issues that were identified for the organization to address throughout the year were:

- Communication
- Engagement at board, regional rep, delegate, and theatre levels
- Board and participant diversification, in order to reach a wider audience

While not listed specifically within the 1-year plan, I did give the Programming Division a goal of putting into place a hybrid adjudicator training program. With less adjudicators active within OCTA over the years, no new adjudicator classes at State Conference since 2019, and the added strain of 8 regions having regionals that would sometimes overlap days, the need to increase the number of trained respondents was becoming increasingly important. The new training program was led by Mary Stone and OCTA respondent trainer DeAnne Bryll and consisted of 3 Zoom sessions over the course of several weeks, during which DeAnne reviewed how to prepare for regionals, watch the excerpt for adjudication, how to respond during the 3 minutes in person response time, and how to prepare written critiques. After the Zoom sessions, the trainees were asked to attend a regional of their choice (participating regionals were Central, Northwest, and West) and were given the chance to adjudicate one of the excerpts, along with the 3 assigned adjudicators. The new program was well-received and successfully added 11 new adjudicators to the roster.

As in 2024, every one of our 8 Regions and OCTA Jr held a Regional Festival this summer! I cannot thank enough all the regional reps for making this happen, as well as the Programming division. While participation in many regions continued to be smaller than in years prior to 2020, there remains hope that

OCTA will continue to grow, and participation will return to previous years! Growing the participation at the regional level will continue to be a focus for the OCTA regional reps.

The 2024-2025 OCTA State Conference is being held over Labor Day weekend, 2025, with Knox Memorial Hall in Mount Vernon as the host theatre. Registration was originally set at \$165; however, due to honest communications with the hotel that had held over a contract put in place from prior to 2020, the conference was able to change venues. That, along with the continued efforts of Jesse Bernal to retain our corporate sponsors - MTI Music Theatre International, Associated Controls + Design, and Concord Theatricals - registration was able to be lowered to \$99 for a full conference package! While registrations are still coming in and final details are still being planned, I truly believe that OCTA Broadway Beach Bound is looking to be a successful conference. The weekend is set to include many workshops from OCTA members and our corporate tech sponsor - 15 excerpts representing each of the 8 regions and OCTA Jr - several inductions into the OCTA Hall of Fame - late night activities meant to appeal to all attendees - a Patron Lounge at the theatre - and many opportunities for all OCTA participants to come together to celebrate Community Theatre.

Great strides were made this year towards furthering the continued goals set forth in the VTO, there are still challenges to overcome. The 2025 State Conference - being led by Conference Chair Kate Charlesworth-Miller - is the first one with our newly defined division of conference responsibilities between the Chair/steering committee and the state board, and we are anxious to see how it goes. I am confident that the dedication and passion of those involved in OCTA on every level will continue to drive OCTA as a whole forward, paving the way for the organization to continue to grow and meet the new demands of supporting the community theatre organization throughout Ohio and our neighboring states!

A lot of time was spent this year reviewing all the Division's policies, with many of them being revised. Of special significance were two new policies, which were adopted by the Board. These were (1) the Code of Conduct on Substance Use during official Events, and (2) a Diversity, Equality, & Inclusion Policy.

Additional time is being allocated for the reviewing of job descriptions and the tasks for which Division members are responsible at the State Conference. Plans were made for this year's Conference (Aug. 29 – Sept. 1, at Knox Memorial Theatre, Mt. Vernon), as well as the 2026 Conference (in Lima), and a search for a 2027 site.

Regional Rep Coordinator Michelle Peterson worked throughout the year with all the Reps, training and planning. She led a meeting with all Reps prior to each Board meeting, reminding them of procedures, policies, and awards. She was the communications link between the Board and the member theatres.

The OCTA Script Library received 3 requests this year, which were handled following the guidelines. A lot of requests were made for some unavailable scripts. These will be looked at for future purchases and inclusion.

Only three Regions submitted nominations for this year's Spirit of Community Theatre Awards – a total of nine nominations. These were discussed within the Division at the May meeting and selections were made for presentations at the three Regional OCTA Fests.

Hall of Fame nominations are submitted each year, as well as any previously submitted nominations being carried forward. All nominations were discussed within the Division at the July meeting and inductees were selected. The formal induction is made at the State Conference.

A motion came from the Delegates at last year's State Conference.to reduce the size of the elected OCTA Board members. Because this would amend the Code of Regulations, it needs to go through the stated process. The issue was discussed in the Division, and a motion was presented to the full Board. This approved motion was sent to all member theatres and Delegates. The final motion will be voted on at the Annual Meeting, where it must receive a two-thirds positive vote to be adopted.

Nominations for the OCTA Board of Directors were sought by Linda Roll. Pending the result of the above-mentioned motion, there will be 5 or 6 three-year terms, plus the filling of a couple of one-year vacancies.

Plans for the Annual Delegates Meeting were coordinated, including annual reports, motions/amendments, and elections, as well as the Delegate meal.

It was a very busy year for the Administrative Division, and I thank all the members for their input and hard work.

MM/PR had several important tasks this year. We started the year off working on individual membership. We added the value of printed newsletter copies and the ability to register via mail for our individual members. This gives our individual members who prefer handwritten forms and publications over technology an appreciated perk. Thanks to the administrative assistant, Aara Wise, we received our request to create standard OCTA emails. Cuelines submissions, Newsletter competitions and MMPR chair emails are organized better, preventing missed communications and easily passing to the next chair. This allows us to use the same entry forms and submission emails year after year, allowing us to work more efficiently and ease submission protocols for our members.

We also finished up on our efforts to address some changes that many felt were needed regarding our rules for Member Theatres, specifically regarding paid actors. A huge thank you to Carissa Sloan for spearheading this project. We were able to suggest a fair policy that allows for member theatres to offer reimbursement to actors, provided they were not paid a living wage. We submitted this to the board, and it was approved to be sent to the delegates for a vote. It is our hope that this will be approved at the next delegate meeting and will open opportunities for membership for those theatres who have been unable to become members in the past.

We also streamlined our social media accounts allowing us to post on Instagram and Facebook at the same time, providing us with continuity in branding. This branding was carried over from our website and onto Cuelines, giving our communications a unified feel thanks to the work of three talented editors/creators: Corbin Wyland, Christina Siciliano, and Andy Roberts. These three worked cohesively to get communication out quickly. Christina worked diligently to put out an accurate newsletter on time, working with the division to ensure accuracy and cooperate with both Andy and Corbin to get the information posted quickly through email subscription, posted on the website, and posted to our social media. We also started an arduous process of getting many of the pictures that have been provided by Jerri Shaffer over the years into albums on our social media presence, working to create a digital history that members can look back on.

Janis Carnahan took over Anniversaries for Peggy Kenney so we can continue to celebrate our member groups' milestone anniversaries with formal recognition from OCTA.

This year five new and returning theaters were presented for membership. All five were approved by the OCTA Board.

MM/PR continues to contribute to the state conference in the areas of publicity, signage, & first timers. The inmemoriam presentation will be designed by Christy Rahrig. We will also be approving the design of the program, which will be designed by Megan Evans of Knox Memorial Theatre.

The division held discussion concerning OCTA policy updates. The updates were completed, submitted, and accepted.

Judging by the feedback the division received, in summary the regional season went well. Thanks to all the people involved with making things run smoothly. Planning is already in motion for State conference, and we expect things to continue to run smoothly.

Thanks to division member Mary Stone, we now have a hybrid responder training course in cooperation with trainer Dee Ann Bryll. It's believed that this first-year pilot program is a success, and all intentions are to maintain the program in future years.

Kate Charlesworth-Miller, being the 2025 State conference chair, will be the Programming division representative as the OCTA board develops a handbook for future state conference chair people.

Items that will be carried over into the next year include:

- 1. Tech survey the division is interested in learning about each theater's tech abilities. The goal is to see if we can alter the lighting-sound-projection regulations to reflect the new trends at future state conferences.
- 2. There was some discussion about investigating the possibility of a black box festival. We intend to keep this discussion going.
- 3. There was some discussion about having regional applications in the future in an online format. It's presently being used in Southwest region and because of its success it's desired to make it available for all regions.

OCTA Responder Training Program Hybrid Approach Final Report 2025

In the past, the OCTA Responder Training Program has provided adjudication training in an in-person format. This year, we designed and implemented a hybrid approach that provided more flexibility for potential responders.

The format was three (3) online sessions via Zoom, and one (1) in person session at a regional conference of the trainees' choice.

- Session 1 (ONLINE): Intro/Information Session (30-45 minutes) Monday, May 12 and make-up date Tuesday, May 13, 2025
- Session 2 (ONLINE): (60-90 minutes) Wednesday, May 14, 2025
- Session 3 (ONLINE): (90 minutes) Wednesday, May 28, 2025
- Session 4 (IN PERSON) Various Regional Conferences

Trainees attended the following regional conferences to watch and evaluate excerpts and provide both a verbal response to the theater group in real time, as well as submitting a written response.

- Central on June 1 at Licking County Players: Newark, OH (2 trainees attended)
- Northwest on June 8 at Maumee Indoor Theatre: Maumee, OH (5 trainees attended)
- West on July 5 at Troy Civic Theatre: Troy, OH (3 trainees attended)

Training announcement sign-ups were sent out via social media, posted to www.OCTA1953.org, and sent to regional reps for distribution. A total of fourteen (14) people initially signed up, and ten (10) completed the full training course.

A master spreadsheet that includes all active responders as well as the 10 newly trained responders has been created for next year's OCTAFest Chairs to use for scheduling.

I believe this hybrid approach to responder training was a great success, and recommend it be implemented again next year, with the in-person conferences to be at the following regionals to bring the training to the eastern and northern parts of the state (dependent on trainer Dee Anne Bryll's availability):

- North
- Northeast
- East
- Southeast

AACT OHIO Report 2025

AACT Region III was held on March 21-23, 2025, at Lebowsky Performing Arts Centre in Owosso, MI, hosted by Owosso Community Players.

Ohio is part of the five-state region: Ohio, Michigan, Wisconsin, Indiana and Illinois. Of these states, all but Indiana sent at least one production. Ohio/OCTA sent 3B Productions' *Bright Star* and Little Theatre Off Broadway sent *The Psychic*. Ohio, Michigan and Wisconsin all had two participants while Illinois only had one participant.

Stage Crafters (MI)-Silent Sky, Verona Area Community Theatre (WI)-Love, Loss and What I Wore, Mandi Theatre (III)-The Carbon Footprint of a Cradle, Kettle Moraine Players (WI)-Under Control, Twin City Players (MI)-A Measure of Cruelty and Ohio sent Bright Star and The Psychic.

Responding for the event were Annette Procunier, David Kilpatrick and Ron Ziegler. All three have served as State Responders for OCTA.

The winners chosen to represent Region III at National AACT were Wisconsin's *Love, Loss and What I Wore* and Michigan's *Silent Sky*. Alternate was Ohio's *Bright Star*.

Bright Star won awards for Outstanding Actress in a Musical-Emma Skaggs, Outstanding Supporting Actor in a Musical-Lane Hakel, Outstanding Supporting Actress in a Musical-Emma Glover and Outstanding Music Direction of a Musical-Janine Baughman. *The Psychic* won Outstanding Props/Scenic Elements.

It was never announced as to the next state to receive the festival, either Illinois or Indiana.

In addition to the Festival, an AACT Responding class was given and OCTA members Theresa Benyo-Marzullo, Dan Maloney, Deb Wentz and Aara Wise all participated and have been certified as AACT Responders. Congratulations to all of them as well.

The state conference was held August 30th through September 2nd at the Midland Theatre and Cherry Valley Hotel in Newark, OH. The theme was "OCTA Out of the Box". As costs continue to rise, the board of directors took over the organization of the annual conference. Using past conference comments and suggestions coupled with the concern for the safety of our participates, they board began the arduous task of finding ways to cut costs, while offering the most requested thing – Excerpts.

Fourteen excerpts were invited, with no alternates used this year. Friday's theme – Straight Outta College had people in their finest college wear registering at the hotel, attending sorority/frat parties and on the hunt for a Show in a Box scavenger hunt. 

- **I.** Call to Order: President Niccole Amersdorfer called the meeting to order at 6:10 p.m. She welcomed all Delegates, Board Members, and Regional Reps to the 2024 OCTA State Conference. She stated that effective January 1, 2025, the annual dues for theatre membership will be raised by \$10.00 to \$75.00 per year. This represents an increase over past years' rate of \$65.00. She asked all present to encourage other participants from their regions and theaters to attend more regional meetings, regional festivals, and the State Conference. She also stated that John Falkenbach, Secretary and Administrative Division Chair, had passed away in November 2023, and that Susan Barzda was appointed the secretary, with Niccole Amersdorfer assisting as needed for the Administrative Division, in addition to her presidential duties. The President's report can be found on pages 3 and 4 of the Annual Report.
- **II. Secretary's Report:** Susan Barzda reported that the Secretary's Report can be found in the Annual Report on pages 20 and 21. This includes the dates of meetings, any actions taken at meetings and the attendance report for board members and regional reps by region. *-Susan Barzda, Secretary*
- III. Financial & Admin. Report: Aara Wise thanked Machelle Miller, Janis Carnahan, and Theresa Benyo-Marzullo for stepping in and completing some of the administrative duties for completion of certificates, and for working on registration for conference, since she had to fill in as conference chair at the State Conference. Aara reported that the Financial Report is found on page 22 of the Annual Report. She stated that OCTA is doing well financially as we received money as grants from other sources (i.e.: MTI, ATI, sponsors for specific events, patrons, and other donations.). Currently there is \$46,000 in the bank account to be used for paying for many of the conference events. At this time, OCTA needs a tax accountant. IV. Division Reports:

The division needs to continue to rewrite / update policies and job descriptions as needed due to divisions taking on the tasks and assignments previously done by the

administrative assistant.

- **B.** Programming- Wayne Kirsch stated that his report can be found on page 9 of the Annual Report. He attended shows from many theaters around the state this year as president (in 2023), and as 1st V.P. of Programming (in 2023 and 2024) to introduce himself and discuss any concerns that theaters may have regarding OCTA. He reported that all Eight regions of OCTA held regional festivals in 2024, and that OCTA Jr. was held. The venue was changed from Mt. Vernon to the Northwest since most of the OCTA Jr. participants were from the Northwest area. Wayne Kirsch, 1st V.P., Programming Chair
- C. Marketing / Membership- Carissa Sloan state that the MM/PR division report can be found on page 8 of the Annual Report. Marzullo, and Judy Berrens for filling in for her at registrations. The Huntington Bank updates will be done at board retreat for regional reps. The lead Regional Reps will have a checkbook, as all accounts will go from savings accounts to checking accounts. Money from the best-dressed box contest will be used to purchase an app to make writeable documents. In the future we need to assess the registration process to see if Hometown or another process is the best process to use for registration.

The OCTA Board retreat will be held at Crowne Plaza Columbus North on October 18,19, & 20. The Admin division will be led by Wayne Kirsch as the immediate past president. AACT responder training will be offered at Region III of AACT in 2025.

East Region

The wheel of progress moves ever so slowly, but it moves nonetheless! That is the best way to describe what the East Region has accomplished this past year.

At the 2024 OCTA State Conference, we added a fourth representative to our region - Jade Boffo of Little Theatre of Tuscarawas County. With the addition of Jade to the hivemind of Nathan Mayse, Machelle Miller, and Christy Rahrig, we aptly dubbed ourselves "The Quad Squad." The Susans (Susan Barzda and Susan Metz-Guthrie) also agreed to serve as board members. The Quad Squad and the Susans looked forward to all that was to happen this coming year!

Our year was peppered with in-person meetings at various restaurants in our region as well as virtually over Zoom. Our first meeting was on Sunday, September 22, at The Forum in Cambridge. At this meeting we discussed possible locations for our 2025 Regional; Triple Locks Theater in Coshocton and Dover High School were considered, since we have held regionals there the previous two years. It was determined whoever was available in early or mid-June would be our preferred choice. Machelle Miller followed up and secured Dover High School for Saturday, June 14.

We had our second in person meeting at the New Philadelphia Tlaquepaque on Sunday, November 10. We couldn't remember what we wanted to talk about, but at least the food was great!

Being the savvy fundraiser she is, Machelle Miller worked on obtaining a corporate sponsorship to help offset the costs. An anonymous member of The Little Theatre of Tuscarawas County offered to cover \$1,000 in expenses for the 2025 East Regional! This was announced via Facebook Messenger on November 27. Happy Thanksgiving to us!

By the start of the new year, we had secured our regional location and had most of the impending costs fully funded thanks to the generosity of the anonymous donor. Because these two usually big issues were already taken care of, that allowed us to focus on confirming excerpts from member theatres for June 14. Through Zoom and Facebook Messenger, we confirmed that at least two theatres were planning to come to the Regional - Little Theatre of Tuscarawas County, and Zanesville Community Theatre, which had not participated in a regional in well over a decade.

Our next meeting was Saturday, April 5, at The Warehouse in Coshocton. Two theatres were confirmed to excerpt, and two theatres (one pending membership approval) were still to be determined. By the May 17 board meeting, it was confirmed the East Regional would have three excerpts: Waterford Players (newly approved for membership!), Zanesville Community Theatre, and the Little Theatre of Tuscarawas County. Coshocton Footlight Players hope to excerpt again in 2026.

Regretfully, Susan Metz-Guthrie had to resign from the OCTA board due to ongoing health issues. We hope to find another person in the East Region who can serve on the board along with Susan Barzda and work with the Quad Squad.

June 14 came and what a wild day it was! Dover High School was incredibly generous in their hosting efforts for OCTA. Northeast Region

Our previous lead NE Regional Representative, Theresa Benyo-Marzullo was elected to the OCTA Board and trained to be an additional OCTAFest Chair to help with the 8 regional festivals and OCTA Jr. Festival this year. She has stayed active in the region though by updating the NE OCTA Facebook page and visiting many of our member theaters and encouraging other community theaters in the NE region to join OCTA. Andrienne Wise began her second year as a NE Regional Rep and along with our new NE Lead Regional Rep Sue Cohen, they worked to build our region by visiting all our theaters, encouraging them to

excerpt at our regional festival, and visiting other community theaters in our region to encourage them to join OCTA.

After the OCTA Board Retreat in October, the first NE Delegates meeting was held on November 16 at Stow Players where we welcomed our NE delegates to a new season. The Northeast Region held a delegates meeting on Nov. 16th hosted by Stow Players. There were 5 theaters represented; Dynamics Community Theatre, Stow Players, Twin Masks Performing Arts Center, Trumbull New Theatre, and Old Towne Hall which we were happy to welcome back to the NE Region. Topics we covered included highlights of the Board retreat, the increase in Theater dues and a summary of what the dues include. We discussed the location and dates of our Regional; Twin Masks had offered to host and there was a discussion about that as well as some other possible locations. Twins Masks is limited in seating but does have all the other technical requirements to host and the main concern with the limited seating was the number of people that normally attend the awards. We were very excited to announce the dates for our Regional with be June 7/8th hosted by Twin Masks Performing Arts Center. We will be encouraging our theaters to bring a smaller show with minimal set pieces hopefully resulting in more participation in our Regional. After the meeting, we watched a production of "God of Carnage" at Stow Players.

Our next meeting was on Feb. 15th at Twin Masks Performing Arts Center (TMPAC). There were 6 theaters represented including our newest OCTA member theater Gates Mills Players. We updated our delegates on items from the OCTA board meeting in January, particularly the information on the new location for the State Conference. We let the delegates know that the excerpts will be performed in a theater as well as the reduction in meals at Conference which will save on the cost of registration. We had a lively discussion on our registration cost for the Regional; we are looking at \$15 across the board but have not finalized that decision. We discussed the Regional and Claudia from TMPAC showed us how she plans on setting up the stage and where the dressing rooms and green rooms will be. We also had a member from Stow Players measure for draping to accommodate more exits and it looks like that will be a great option for the Regional. We discussed where to have the next delegates' meeting and the deadline for Registration and the date for Walk the Stage, came up with some tentative plans. We invited everyone to stay for dinner at a local restaurant and then return for Twin Mask's production of Constellations, the opening show of their season.

We had a Zoom meeting on April 10 to go over the paperwork needed to enter an excerpt into our regional festival.

Our Regional was held at Twin Masks Theater on June 7, with 4 excerpts, including one first time theater excerpting and one that had not participated in quite a few years. Everything went very well, and we believe our first Black Box Regional was very well received and went off without a hitch. We did have smaller shows for excerpts, but we did not hear any major complaints, and the evaluation forms were very positive. We also held regional Rep Elections, and 5 theaters took part in this. Claudia Lillibridge, one of the co-founders of Twin Masks was elected, along with returning Reps Adrienne Wise and Sue Cohen. Adrienne and Claudia will be colead Reps. Twin Masks did a fabulous job hosting and made everyone feel very welcome. Our only wish was that we made more money for the coming year but due to the smaller shows and a very reasonable entry fee that did not happen. After paying all the things our Region was responsible for we have \$447.73 to get us through the year. And NE Rep Sue Cohen would like to recognize Adrienne Wise and Theresa Benyo-Marzullo for running this year's Regional without her. They did a fabulous job!

Challenges

• Financial Knowledge:

Current financial details for the Northwest Region are unavailable, as the necessary paperwork is still being processed. Updates will be provided as this information becomes accessible.

The Northwest Region remains committed to enhancing community involvement, supporting local art, and strengthening delegate connections as it prepares for upcoming events and initiatives.

Representative Meeting (December 29): A meeting was held with representatives about preparing for regionals as well as completing paperwork. A contract has been completed and is actively being sent to the Maumee Indoor Theatre (by Zach Montri) to finalize the rental agreement. A digital version of the contract will be sent when Sara Eiden (manager of MIT) completes the contract. We will then only be waiting on funds to complete the rental.

• New Member On the Horizon: We have a very eager youth group looking to join OCTA from NW region! Horizon Youth Theatre has been actively working with Eve Barman to become an OCTA theatre. Eve is currently in communication with their board to assist in their paperwork.

Future Goals

- Regional Competition Growth: The Northwest Region wants to encourage community even at the competition. It has not been publicly disclosed; however, we are looking to give out awards to all member theatres (not just those participating in competition) to further recognize those that don't have an interest in competing. A yearly award series will hold reps accountable for seeing shows, while also shining light on all member theatres.
- Post Competition Goals: We saw theatres struggle with cost for last year's State Competition. We want to relieve this by helping the theater's fundraiser. Although not publicly disclosed, the representatives are working towards a monologue jam that would be planned after the regional competition in order to fundraiser for NW competitors. Monologue Jams are easier to acquire rights for, and we are actively working with our competition location (the Maumee Indoor Theatre) to find a day to host this event!

• 2025 Regional Competition Venue Secured:

Southwest Region

The 2024-2025 season proved to be a very successful one in Southwest. With a mix of veteran and new regional reps, the focus was on outreach and making sure groups were kept in the loop and that their voices were heard. Our regional reps were **Judy Berrens**, **Jane Culp**, **John Masterson**, **Kevin Noll**, **Linda Roll**, and **Mary Stone**. Mary assumed the lead rep position for the first time, taking over from Kevin Noll. In addition to the regularly scheduled monthly ACT Cincinnati meetings held on the 4th Tuesday of the month (except for July, August, and December), each rep was assigned to a short list of 3-4 theater groups and attended each of these group's board meetings to put a more personal face to OCTA and to give the groups someone to reach out to with questions or concerns. The groups seemingly appreciated this 1:1 time with the OCTA reps.

Southwest also gave member groups an anonymous online survey to ask what they would like to see at future OCTA State conferences. The final tabulation was **45 responses** from **11 different groups**. The results were as follows:

- 71% said they would be more likely to attend State if it were reduced to 3 or 2 days
- 67% said they would be more likely to attend State if it were not on Labor Day weekend
- 71% said they would still attend State if there were no Sunday banquet or Monday brunch
- 82% said they would prefer to get their own dinner on Sunday after excerpts and come back after 2 hours for an awards ceremony vs. formal banquet
- 93% said they were interested in excerpts by their home theater
- 91% said they were interested in excerpts by other theaters from other regions, not their home theater
- 56% said they were interested in workshops
- 18% said they were interested in the Sunday banquet
- 7% said they were interested in Friday night games
- 2% said they were interested in the Monday morning brunch

The regional festival was held for a 2nd year in a row at Princeton High School's Matthews Auditorium, which has proven to be a centrally located, excellent state-of-the-art facility. This year there were 11 groups excerpting, down from the 13 groups that excerpted in the 2023-2024 season, with 4 groups performing on Friday, June 20 and 7 groups performing on Saturday, June 21. Three groups were invited to perform at State: The Footlighters, Inc., The Drama Workshop, and Loveland Stage Company, with Sunset Players chosen as the alternate. Bruce Jacklin, Pat Potter, and Deb Wentz served as responders, the newly trained Theresa Benyo-Marzullo was the OCTAFest chair, and Aara Wise was the administrative assistant. Southwest also pioneered an online theater entry form (and substitution form) this year, allowing groups to submit all their paperwork via a Google form. The feedback from the directors, producing groups, and program

designer was overwhelmingly positive, and with some learnings about what specifically is needed in what format for the OCTAFest chair, some adjustments can be made to make the online form even more effective next year.

Next year's regional reps have already been selected, with two fantastic additions to the roster: **Phil Catlin** and **Mark Culp** will join **Judy Berrens**, **Jane Culp**, **John Masterson**, and lead rep **Linda Roll**.
